- Oral evidence to the Senior Salaries Review Body (SSRB) will be given on 15 January 2025 and evidence on the Cabinet Secretary appointment will be given to the Public Administration and Constitutional Affairs Committee on 28 January 2025.
- An announcement on the 2024 Commissioner's Mark of Excellence (CME) award will be made shortly.
