Dear Heads of Department,

- **Queries on, and applications under, the Business Appointment Rules for senior civil servants and special advisers should now be sent to bars@csc.gov.uk.**
- **Further information on departmental BARs audits will follow.**

The government has [announced](#) that the Advisory Committee on Business Appointments (ACOPA) will close, and that as of 13 October 2025 the Civil Service Commission (the Commission) will take on a new role providing independent advice on, and scrutiny of, the application of the Business Appointment Rules (the Rules) for senior civil servants and special advisers.

As of 13 September, applications under the Rules for current and former senior civil servants at Director General level and above (SCS Pay Band 3 / equivalent and above) and senior special advisers (Pay Band 4 and equivalent) should therefore be submitted via the department to the Commission via bars@csc.gov.uk.¹ All queries on the application of the Rules to these cohorts should also be sent to this address.

Advice cannot be issued until the Commission assumes its new role on 13 October.

ACOPA will be in contact with applicants directly if their application was submitted prior to 13 September. Advice considered and provided by ACOPA before it closes on 12 October, but taken up or announced by the applicant on or after 13 October, will be published on the Commission's website. The Commission will not have considered these applications.

The Commission has also been [asked](#) to:

- Commence regular audits of departmental performance considering BARs cases. Next steps on this process will be communicated later in the autumn.
