- Exceptions at and above the SCS Pay Band 2 level require the prior approval of the Commission. This table provides details of exceptions reported to the Commission as a result of class/bulk approvals at or above the SCS Pay Band 2 threshold (or equivalent) during 1 April 2025 30 September 2025.
- Class approvals allow government departments to make multiple exceptional appointments, under a specific set of conditions, prior to identifying the individuals to be appointed and without the need to seek approval from the Commission for each case.
- Bulk approvals allow government departments to make multiple appointments by exception to a group of named individuals without the need to seek approval from the Commission for each case.
- Both class and bulk approvals are rare and only granted where a department can demonstrate a clear and compelling business need. Where such approvals are given, specific parameters are set to ensure that appointments are made strictly in line with defined conditions. In addition, the department must report the relevant details of each appointee to the Commission at regular intervals.
- This data is published every six months.
- The data does not include appointments where the name has been redacted for confidentiality reasons or when an individual subsequently declined and did not start in post.
- Exception rules are outlined in the <u>Recruitment Principles</u> (p11). Secondments (Exception 3) are counted as exceptions even if a fair, open and merit-based competition has taken place to identify the appointee.
